Scope of data retrieval:

- Standard Only accesses data that the phone's operating system readily provides, including files like call logs, messages, contacts, and some app data. It's comparable to what a user would see in their device interface.
- Premium Goes deeper to access the entire file system, including deleted data and system files. This can uncover more detailed information such as location history, encrypted app data, and more.

Level of Access:

- Standard Limited to user-accessible data and what the device's default security settings permit.
- Premium Utilizes advanced methods to bypass security features and encryption, enabling access to practically all data on the device.

Type of Data Recovered:

- Standard Recovers basic user data: texts, call history, contacts, photos, and some app data.
- Premium In addition to standard data, it can recover hidden, deleted, or encrypted files, including system logs and deep app data.

Time and Resources:

- Standard Quicker and less resource-intensive.
- Premium More time-consuming and requires more advanced technical expertise and tools.
